The appellant states that he is satisfied with the information so supplied by the respondent in this case but the respondent-Public Information Officer has not paid the compensation amounting to Rs.20,000/- (Rupees twenty thousands only). However, the respondent-Public Information Officer states that the compensation amount will be paid to the appellant within 15 days from the state exchequer.

3. Accordingly, the respondent-Public Information Officer is directed to pay the compensation amount to the appellant from the state exchequer within 15 days and also send a copy of the bank draft to the Commission for record. With these directions the case is disposed of and closed. However, the liberty is granted to the appellant to approach the Commission within four weeks in case he does not receive the compensation amount from the respondent-Public Information Officer. Sd/
