ORDER

This order may be read with reference to the previous order dated 1.11.2021.

2. The appellant has sought the following information:-

“ਜਨਵਰੀ 2015 ਤੋਂ ਲੈ ਕੇ 8 ਜੁਲਾਈ 2020 ਤੱਕ ਨਜ਼ਾਇਜ਼ ਕਬਜ਼ੇ ਵਾਲੀਆਂ ਜ਼ਮੀਨਾਂ ਛੁਡਵਾਉਣ ਲਈ ਵੱਖ ਵੱਖ ਸਾਧਨਾਂ ਰਾਹੀਂ ਕੀਤੇ ਗਏ ਖਰਚ ਦੀ ਪ੍ਰਤੀ ਸਾਲ/ਪ੍ਰਤੀ ਪੰਚਾਇਤ ਦੇ ਹਿਸਾਬ ਨਾਲ ਜਾਣਕਾਰੀ ਦਿੱਤੀ ਜਾਵੇ।”

3. The appellant states that he is satisfied with the information so supplied by the respondent in this case but the respondent-Public Information Officer has not paid the compensation amounting to Rs.20,000/- (Rupees twenty thousands only). However, the respondent-Public Information Officer states that the compensation amount will be paid to the appellant within 15 days from the state exchequer.

3. Accordingly, the respondent-Public Information Officer is directed to pay the compensation amount to the appellant from the state exchequer within 15 days and also send a copy of the bank draft to the Commission for record. With these directions the case is disposed of and closed. However, the liberty is granted to the appellant to approach the Commission within four weeks in case he does not receive the compensation amount from the respondent-Public Information Officer.

ORDER

2. The appellant has sought the following information:-

2. Supply me copy of rules in which capacity and in which law he did the proceeding and recommended the name of Rajesh Kumar no suitable for job.

3. The representative of the respondents states that the compensation amounting to Rs.10,000/- (Rupees ten thousands only) has already been paid to the appellant and the remaining Rs.5,000/- (Rupees five thousands only) will be paid to the appellant within a week. He has also sent a whatsapp message in this regard, which is taken on record.

4. Accordingly, the respondent-Public Information Officer is directed to pay the remaining compensation to the appellant as has been assured during the hearing. With these directions, the case is disposed of and closed. However, the liberty is granted to the appellant to approach the Commission within four weeks in case he does not receive the remaining compensation as enumerated above.

Since the appellant is absent, therefore, the liberty is granted to him to approach the Commission within four weeks in case he has any submissions in this case, for the consideration.
