Transfer of Transformer in front of SCO situated at Ranjeet Avenue (97 acres Scheme) D block Amritsar, At the time of Auction by Improvement trust Amritsar is sell the land near Army headquarter wall, But after the dispute Improvement Trust shift the land, but now the problem arise that some electricity transformer come in front of SCO, and at that time PCS officer (Chairman Improvement trust Amritsar) Ranjit kaur verbally committed that these transformer will be shifted backside of SCO, till date after complaint online from connect punjab portal dated on 2021-08-04 grievance ID 20210036383 is not been answered by any authority. 1 When these transformer being shifted? 2 Reason for no action taken on these complaint?

3. The appellant has sought the information related to Grievance ID No. 20210036383 filed on the Punjab online portal on 04.08.2021. According to the Punjab portal, the grievance of the appellant has already appeared as 'Resolved'. The appellant also reiterated the same during the hearing. The appellant further submitted that the department should have transferred the transformer situated in front of SCO at Ranjit Avenue (99 Acres Scheme), D-Block, Amritsar, as it creates hindrance to the general public, in the public interest.

4. According to the submissions made by the appellant, a copy of the case file is **being sent** to the Principal Secretary, Government of Punjab, Department of Local Government, Sector 35, Chandigarh and to the Deputy Commissioner-cum-Chairman, Improvement Trust, Amritsar to look into the matter and take appropriate action in the public interest.

5. As far as the RTI application of the appellant is concerned, no further action is required to be taken, as per the provisions of the RTI Act as the appellant has sought the information in question form. Accordingly, the case is disposed of and closed.

3. The representative of the respondents submits that the Human Rights Commission has sent the reference to the Deputy Commissioner, Jalandhar and the said office has already referred the matter back to the Human Rights Commission. He further submits that no such document has been received from the Human Rights Commission by the Deputy Commissioner, District Ludhiana. He has also sent the written submissions in this case, which is taken on record. A copy of the submissions so received from the respondent are also being sent to the appellant along with this order.

4. Keeping in view the specific reply filed by the respondent, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed.

## ORDER

This order may be read with reference to the previous order dated 31.03.2022 vide which the 3<sup>rd</sup> party involved in this case i.e. Dr. Ashok Paul was served a notice through email ID along with the RTI application as to why information related to him may not be supplied to the appellant. It was also clarified to him that in case of non submissions before the next date of hearing the case will be decided ex-parte on merit and the case was adjourned for today i.e. 25.5.2022.

2. The appellant has sought the information related to Dr. Ashok Paul, Dean and Professor in the physics department of Desh Bhagat University.
3. Neither has the 3<sup>rd</sup> party i.e. Dr. Ashok Paul given any submissions nor is he present on the date of hearing.
4. It is also appropriate to mention Section 10 which provides –

*(1) Where a request for access to information is rejected on the ground that it is in relation to information which is exempt from disclosure, then, notwithstanding anything contained in this Act, access may be provided to that part of the record which does not contain any information which is exempt from disclosure under this Act and which can reasonably be severed from any part that contains exempt information.*

*(2) Where access is granted to a part of the record under sub-section (1), the Central Public Information Officer or State Public Information Officer, as the case may be, shall give a notice to the applicant, informing—*

*(a) that only part of the record requested, after severance of the record containing information which is exempt from disclosure, is being provided;*

*(b) the reasons for the decision, including any findings on any material question of fact, referring to the material on which those findings were based;*  
*(c) the name and designation of the person giving the decision;*  
*(d) the details of the fees calculated by him or her and the amount of fee which the applicant is required to deposit; and*  
*(e) his or her rights with respect to review of the decision regarding non-disclosure of part of the information, the amount of fee charged or the form of access provided, including the particulars of the senior officer specified under sub-section (1) of section 19 or the Central Information Commission or the State Information Commission, as the case may be, time limit, process and any other form of access.*

6. After going through the submissions made by the parties, the directions are issued to the respondent-Public Information Officer to supply a copy of the Bio-data/Curriculum-vitae to the appellant after severing the family information, if any, as per Section 10 of the RTI Act, 2005 mentioned herein, within 10 days. The respondent-Public Information Officer has agreed to comply with the directions.

7. Accordingly, the case is disposed of and closed. However, the appellant is at liberty to approach the Commission within three weeks, if she does not receive the requisite information.
