ORDER:

1. The RTI application is dated **3.2.2020** vide which the appellant has sought information **regarding letters sent to senior Environmental Engineer, Jalandhar**, as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on **5.3.2020** and second appeal was filed in the Commission on **11.9.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard on **21.1.2021**.

2. The appellant is absent for the second successive hearing. The respondent PIO represented by Atul Kaushal, Assistant Environmental Engineer, is present via Video Conference from Jalandhar. At the last hearing on 21.1.2021, the appellant had contended that the information supplied to him was not certified. In consequence, the respondent PIO was served with a Show Cause Notice.

3. The respondent PIO has made a submission vide Letter No. 3927 Dated 24.8.2020, in response to the Show Cause Notice issued to him, wherein he has stated that the requested information was sent to the appellant twice. First time vide Letter No. 2088 Dated 16.6.2020 and once again after this Commission's Order of 21.1.2021, vide Letter No. 936 Dated 23.2.2021. A copy of the information furnished to the appellant has also been submitted to this Commission. There has since been no communication from the appellant which compels the Commission to conclude that the appellant is satisfied with the information supplied to him by the respondent PIO.
