Shri Darbara Singh, HC, on behalf of respondents.

**ORDER:**

The representative of respondents reiterates his earlier stand that the sought for information has already been supplied to the appellant.

2. The appellant is absent without any intimation to the Commission.

3. A perusal of record available in the case file reveals that in this case nine hearings have been held till date and the appellant attended only one hearing on 09-11-2017. He remained absent on eight consecutive hearings. On many occasions the appellant had sought exemption on telephone on one pretext or the other, but he never attended the court.

4. Therefore, the appellant is provided last and final opportunity to be present in the court on the next date of hearing. In case of non appearance it will be assumed that he is satisfied with the supplied information and the case will be decided on merit. Adjourned.
