On hearing held on 11.09.2019, respondent PIO was absent continuously second time without any intimation to the Commission and compensation was enhanced to Rs. 1,500/- from Rs. 1,000/- and matter was adjourned for further hearing today on 22.10.2019

On 22.10.2019, respondent PIO failed to represent this case as well as he failed to comply with the previous order of the Commission dated 13.05.2019. Due to continuous absence of the PIO despite of due notice(s) and directions under RTI Act, Bailable Warrant was issued to the respondent PIO, on the name of **Sh. Jaspal Singh, PIO, O/o S.U.S. Adarsh Sen. Sec. School, Balad Khurd (Sangrur)** through The Senior Superintendent of Police, Sangrur and matter was adjourned for further hearing today i.e. 26.11.2019.
