In this case, Shri Suresh Aggarwal, Appellant, vide his RTI application dated 04.09.2018, addressed to the PIO of the office of District Revenue Officer, Ludhiana, sought certain information regarding measurement and encroachment of land adjoining Budha Nala. On receiving no information, he filed an appeal with the First Appellate Authority vide application dated 29.10.2018 and subsequently approached the Commission in Second Appeal vide application dated 28.12.2018, which was received in the Commission on 02.01.2019. Accordingly, a Notice of Hearing was issued to the Concerned parties for today.

2. Today, none is present on behalf of the respondents without any intimation. However, a letter No. 333/RTI, dated 26.09.2018 has been received by the appellant from Tehsildar, Ludhiana(East) vide which a report from Parwari/Kanungo has been sent to him. The appellant expresses dis-satisfaction with the provided information. He informs that survey of land was conducted and some encroachments were removed but complete requisite information has not been provided to him so far. Accordingly, Tehsildar(East) Ludhiana and District Revenue Officer, Ludhiana are directed to submit a detailed status report, before the next date of hearing.
