ORDER

1. This order may be read with reference to the previous order dated 29.01.2020.
2. Respondent, Sh. Inderjeet Singh states that penalty amount has already been deducted from the concerned official and requested for an adjournment to submit the challan.
3. Respondent, Sh. Nirmajit Verma is not present for today's hearing but a letter dated 25.02.2020 has been received in the Commission vide diary no. 3708 dated 25.02.2020 stating that penalty amount has already been deducted from his salary but due to strike at Municipal Corporation, Jalandhar office he is unable to produce challan today and requested for an adjournment.
