This order may be read with reference to the previous order dated 6.2.2020 vide which the appellant was advised to establish larger public interest in seeking the information of Mr. Priyank Bharati, IAS before the next date of hearing.

- 2. The respondents/Local Self Government, Punjab, Chandigarh has supplied complete information concerning point at Sr. No. 2 to the appellant to his satisfaction.
- 3. The appellant described the larger public interest involved in seeking the information concerning Mr. Priyank Bharti, IAS, in his application, the extract of which, is as under:-

- 4. The appellant filed an application dated nil for seeking information to PIO, which was received in their office on 03.06.2019. In response to this letter, the respondent-PIO wrote a letter dated 10.06.2019 asking the appellant to establish larger public interest in seeking the information as per Govt. of India's instructions dated 14.08.2013. The appellant sent his reply dated 25.06.2019 with the respondent-PIO, in response to their letter dated 10.06.2019 establishing larger public interest. The PIO has sent reply vide their letter dated 9.7.19 stating that the appellant has failed to establish larger public interest, hence the information sought by him could not be supplied. The appellant filed first appeal before the First Appellate Authority on 03.08.2019 against the order of Public Information Officer. The First Appellate Authority passed, after due application of mind, a comprehensive speaking order on 23.09.2012 accepting the plea of PIO in view of instruction of Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training, New Delhi's letter dated 14.08.2013 circulated the Central Information Commission's decision dated 26.06.2013 in Manoj Arya vs. Central Public Information Officer, Department of Personnel and Training, New Delhi vide which the information cannot be supplied regarding the performance of an employee/officer in an organization as it is primarily a matter between the employee and employer.
- 4. After hearing both the parties and going through the record available on the case file, it is ascertained that the appellant has failed to establish larger public interest in seeking the information. The information sought by the appellant revolves around the note written by the minister against the officer and any possible action might have been taken by the concerned department. The appellate authority was very right in deciding that the information was qualified as personal information within the meaning of the provisions of Section 8(i)(j) of the RTI Act,. In this connection, it is pertinent to cite the decision of the Hon'ble Apex Court in SLP (Civil) No. 27734 of 2012 titled Girish Ramchandra Deshpande vs. Central Information Commissioner and others has held in para 13 of the judgment that:-

"We are in agreement with the CIC and the courts below that the details called by the petitioner i.e. copies of all memos issued to third respondent, show cause notices and orders of censure/punishment etc. are qualified to be personal information as defined in clause (j) of Section 8(1) of the RTI Act. The performance of an employee/officer in an organization is primarily a matter

between the employee and the employer and normally those aspects are governed by the service rules which fall under the expression "personal information", the disclosure of which has no relationship to any public activity or public interest. On the other hand, the disclosure of which would cause unwarranted invasion of privacy of that individual."

In view of the above observations, judgment delivered by the Hon'ble Apex Court as mentioned above and in the absence of establishing any larger public interest by the appellant, the information sought by the appellant cannot be supplied under Section 8(i)(j) of the RTI Act, 2005 as this matter falls under employee and employer relationship. The Commission observes from the nature of information sought by the appellant that he is trying to settle his individual interest rather than any larger public interest. Accordingly, the present case is disposed of and closed. Copies of the order be sent to the parties.
