- 3. As far as the information concerning the Revenue department pertaining to Point No. 4 is concerned, the APIO has filed the specific reply regarding appointment of dependents of terrorist affected in Group C and D service.
- 4. The appellant is absent without intimation. He has also not submitted any deficiencies in the information so supplied by the respondents.
- 5. It is appropriate to mention the instructions issued vide No. 10/2/2008-IR dated 12.6.2008 by the Ministry of Personnel, Public Grievances & pensions, Department of Personnel & Training and the relevant portion of the same is reproduced below:-
 - "3(iii)...It may be noted that the Act required the supply of such information only which already exists and is held by the public authority or held under the control of the public authority. It is beyond the scope of the Act for a public authority to Create information. Collection of Information, parts of which are available with different public authorities, would amount to creation of information which a public authority under the Act is not required to do. At the same time, since the information is not related to any one particular public authority, it is not the case where application should be transferred under sub-section (3) of the Section 6 of the Act. It is pertinent to note that sub-section (3) refer to 'another public authority' and not 'other public authorities'. Use of singular form in the Act in this regard is important to note."
- 6. Keeping in view the above, the complainant is advised that in case he intends to seek the information from more than one public authority, he may seek the same from the concerned department. As such no further action is required to be taken in this regard. Hence, the case is disposed of and closed. However, the liberty is granted to the complainant to approach the Commission within 10 days in case of any submissions for consideration.
