Present : The Complainant, Sh. Harjit Singh is absent.
Ms. Nitu Saini, Senior Assistant from DRA Branch office of DC, Sangrur is present.

ORDER:

On the last hearing dated 29.03.2022, the Senior Assistant, Sh. Vikramjeet mentions that the information has already been supplied to the Complainant but on the other hand, the Complainant was absent on that hearing i.e. 29.03.2022, so an opportunity was given to him to appear on the next date of hearing for clarifying the facts of this case.

In today's hearing, the Complainant, Sh. Harjit Singh is again absent without any intimation to the Commission.
