ORDER

1. This order may be read with reference to the previous order dated 30.05.2022 vide which appellant stated that the pending information is still to be received.

The respondent stated that information at point No.4 & 5 relates with SSP, Bathinda that can be had from that office. He further states that information relating to point 2, 3, 4 & 14 are voluminous. The court directs the respondent only number of challans done and amount received/deposited may be given before the next date of hearing.

Appellant was advised to visit office of the respondent on 1.6.2022 during office hours and get the record inspected and point out the information so that the same can be supplied to him on his visit.

Respondent PIO, Sh. Mukesh Bhatia is directed to supply the information relating with RTA Office, Bathinda as per RTI application on the appellant's visit. Matter was adjourned for further hearing on 26.07.2022 i.e. today.

2. In today's hearing, both the parties are present.
3. Respondent, Ms. Kulwinder Kaur states that earlier 54 pages have been supplied and 06 pages have been supplied today.
4. Respondent, Sh. Mukesh Bhatia states that requisite information had already been sent to the appellant on 25.07.2022 i.e. yesterday. A copy of the same is sent to the Commission via an email dated 25.07.2022, which is received and taken on record.
5. After discussing with both the parties and examining the case file, it is observed that sufficient information had already been supplied to the appellant. Therefore, no further cause of action is required in this case. Hence, this instant case is **disposed of & closed**. Copy of the order be sent to the parties.

ORDER:

1. This order may be read with the reference of previous order dated 30.05.2022 vide which respondent, Sh. Sukhdeep Singh brings the original record and after inspection, appellant identifies 67 pages but respondent, Sh. Sukhdeep Singh mentions that only 25 pages will be supplied to the appellant except ਐਲ. ਓ. ਸੀ. ਅਤੇ ਜਿਸਨੀ ਰਿਪੋਰਟਾਂ, which cannot be supplied.

Appellant requested for an adjournment to decide the matter after going through the supporting documents (compromise deed), which he will send today or within 2-3 days. Appellant was advised to send the documents on which he is taking plea immediately. Matter was adjourned to 26.07.2022 i.e. today.

2. In today's hearing, respondent, Sh. Sukhdeep Singh states that whatever information was to be given had already been supplied and rest of the information could not be supplied. He submits a reply in this regard vide letter dated 20806 dated 26.07.2022, which is taken on record.
3. Appellant is not present for today's hearing despite being aware about the date of hearing. A call was made to him in this regard. Documents sent by the appellant (compromise deed) on 31.05.2022 through whatsapp, is taken on record.

After hearing the respondent and examining the documents placed on record, I am of the considered view that supplied reply is satisfactory and sufficient information had already been supplied to the appellant. Therefore, no further cause of action is required in this case. Hence, this instant case is **disposed of & closed**. Copy of the order be sent to the parties.
