was imposed upon PIO of office of Regional Transport Authority, Sangrur.

Sh. Karanvir Singh Chhina, Secretary-cum-PIO, who appeared in person in today's hearing, submits a reply vide letter no. 10424 dated 22.08.2019 signed by Public Information Officer-cum-Secretary, Regional Transport Authority, Sangrur, stating that the complainant has been informed vide letter no. 8459 dated 23.04.2019 that there is no provision in the RTI Act, 2005 to prepare or create information as laid down under Section 7(9) of the Act and therefore, the list of vehicles of other States, which have been re-registered cannot be prepared and in regard to photocopies of NOCs of the vehicles, he was informed that the same being 3rd party information is exempted from disclosure as per Section 8 (1) (d) of the RTI Act. Through the abovementioned reply the respondent PIO has also requested to waive off the penalty imposed upon vide orders dated 03.07.2019. Appended to the abovementioned reply, a copy of another reply vide letter no. 8459 dated 23.04.2019, showing that the complainant has also been intimated about this fact. It, alongwith a copy of reply vide letter no. 8459 dated 23.04.2019, is taken on record.

The complainant, Sh. Balvir Singh Sidhu, through a letter dated 25.08.2019, which has been received in the Commission through an e-mail, has intimated the Commission that he is unable to attend today's hearing and requested for an adjournment in this case. It is taken on record.

The respondent PIO concerned is directed to file a written-reply, in the shape of an affidavit, to the queries raised by the complainant through his RTI request as per official record by or on the next date of hearing.

Sh. Karanvir Singh Chhina, Secretary, RTA, Sangrur, also made an oral-submission that he was PIO-cum-Secretary, RTA, Sangrur, when the RTI application dated 12.11.2018 was moved by the appellant, afterwards he got transferred and presently he has joined as Secretary, RTA, Sangrur recently i.e. just after the elections. After going through the oral submission made by Sh. Karanvir Singh Chhina, Secretary, RTA, Sangrur during the hearing and reconsidering the written submission vide letter dated 22.08.2019 submitted by the respondent PIO, it is found that the explanation given by the respondent PIO concerned is genuine and facts of the instant appeal case deserve reconsideration in the interest of justice. Taking a lenient view and having made the fair and judicious evaluation of the facts of the instant appeal case, it is found that the reasons given by the respondent PIO concerned is genuine and in this particular case, he (PIO concerned) has succeeded in convincing the Bench that there is no malafide intention on his part in causing the delay in supplying the requisite information to the information seeker as well as appearing before the Commission.

Hence, penalty imposed upon the concerned PIO vide orders dated 03.07.2019 is <u>waived off</u> and show cause issued vide orders dated 14.05.2019 is **dropped.**

ORDER

This case was last heard on 03.07.2019 and last opportunity was given to the respondent PIO concerned to facilitate the appellant to inspect the relevant official record on 24.07.2019 at 11:00 A. M. so that the appellant could identify the required information and the Executive Engineer would ensure the presence of the concerned Superintendent or PIO during the inspection of the official record. The Appellant was also advised to avail the opportunity to inspect the relevant official record on 24.07.2019 at 11:00 A. M. to identify the information. The respondent-PIO concerned was also directed to supply the information, which would be identified after inspection, to the appellant as per official record.

Sh. Nirmal Singh, Clerk, appeared on behalf of the respondent PIO in today's hearing but he is not fully aware of the facts of the instant appeal case.

The appellant, Sh. Pawan Kumar, who appeared in person in today's hearing, orally states that he has visited the office of the respondent but till date no information has been given to him.

The Commission took a serious view of this casual approach of the respondent PIO.

In view of the above, a show cause notice under Section 20 (1) of the RTI Act is issued to Public Information Officer of office of Executive Engineer, Construction Division, PWD B & R, Gidderbaha, as to why penalty be not imposed upon him for willful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the information-seeker under the provisions of the RTI Act, 2005.

The PIO is also hereby given an opportunity under Section 20(1)

provision, thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte. A copy of this order be sent to him through registered post.

Another opportunity is also given to the respondent PIO concerned to supply the certified copies of the required information to the appellant through registered post at his residential address before the next date of hearing and produce a copy of the postal receipt, through which information would be sent to the appellant, before the Commission on the next date of hearing.

An opportunity is also given to the appellant to confirm whether he has received the information or not. He is also advised to point out deficiencies, if any, in the information supplied to him, in writing, to the respondent PIO so that the same could be removed by the respondent concerned. He is also advised to represent his case in person or through his representative on the next date of hearing.

Sh. Harinder Singh Dhillon, the concerned Executive Engineer,
Construction Division, PWD B & R, Gidderbaha is directed to appear in person before
the Commission on the next date of hearing so that the facts of this case could be
cleared. A copy of this order be sent to him through registered post.
