ORDER

1. The RTI application is dated 22.05.2018 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) and second appeal was filed in the Commission on 10.06.2019 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for 26.08.2019 in the Commission.
3. Respondent files his reply which is as under:-

Copy of the application available on record is attached as Annexure 'A'. From the record available in this office it is clear that Gurmeeet Kaur made a representation dated 13.06.18 whereby she informed the office that the applicant is father-in-law of her daughter and there is a matrimonial dispute giving rise to Domestic Violence being forced by her daughter at the hands of applicant and his family members. She requested that the information may not be supplied to the applicant as he has personal vendetta against her. She invoked the provision of Section 11 of the RTI Act. Copy of the representation dated 13.6.18 available on the record of this office submitted by Gurmeeet Kaur is attached as Annexure B. Thereafter my predecessor passed the order dated 4/7/18, copy of which is Annexure 'C' declining the information by invoking the section 11 of the RTI Act. Section 8 (G) & (J) of RTI were being used in to refuse the information to the applicant. It is denied that there is any favour or favouritism exercised by my predecessor while declining the information to the applicant as

4. I have gone through the reply and found that the information demanded by the complainant is third party information. The appellant may take note that there is judgment of Hon'ble Supreme Court of India in SLP no. 27734 of 2012 titled Girish Ramchandra Deshpande Vs Cen. Information Commr. & Ors and another in its order on 03.10.2012 has held as under:-

(13. We are in agreement with the CIC and the courts below that the details called for by the petitioner i.e. copies of all memos issued to the third respondent, show cause notices and orders of censure/punishment etc. are qualified to be personal information as defined in clause (j) of Section 8(1) of the RTI Act. The performance of an employee/officer in an organization is primarily a matter between the employee and the employer and normally those aspects are governed by the service rules which fall under the expression "personal information", the disclosure of which has no relationship to any public activity or public interest. On the other hand, the disclosure of which would cause unwarranted invasion of privacy of that individual. Of course, in a given case, if the Central Public Information Officer or the State Public Information Officer of the Appellate Authority is satisfied that the larger public interest justifies the disclosure of such information, appropriate orders could be passed but the petitioner cannot claim those details as a matter of right).

5. In view of the foregoing, no cause of action is left, the appeal filed by the appellant is therefore **disposed of and closed**. Copy of the order be sent to the parties.

ORDER

This order may be read with reference to the previous order dated 23.07.2019 vide which the respondent was directed to provide complete information to the appellant within one week.

2. Today, Sh. Rajesh Kumar, Counsel is appearing on behalf of the appellant states that no information has been given to the appellant so far.

3. Respondent is absent today.

4. The perusal of the file shows that the appellant filed RTI on 03.01.2019, but information has not been provided to him so far, which shows that the respondent has no regard for the orders. Even the respondent has not bothered to attend the hearing in the Commission. This is indeed a serious matter.

5. This has resulted in much avoidable inconvenience and hardship to the Appellant. He is, therefore, entitled to be compensated under Section 19(8)(b) of RTI Act 2005 for the loss and detriment suffered by him. In the circumstances, I am of the view that ends of justice would be met if a sum of **Rs.1500/- (Rupees Fifteen hundred Only)** is awarded to the Appellant as compensation. I order accordingly.

6. This amount shall be payable by the Respondent from the State exchequer within fifteen days from the receipt of this order under intimation to the Commission.

ਜਿਥੇ ਤੱਕ ਕਾਰਵਾਈ ਦਾ ਸਬੰਧ ਹੈ ਮਾਨਯੋਗ ਅਦਾਲਤ ਨੂੰ ਲਿਖਤੀ ਬੇਨਤੀ ਹੈ ਕਿ ਜੋ ਮਕਾਨ ਲਾਲ ਲਕੀਰ ਦੇ ਅੰਦਰ ਹੈ ਉਸ ਦਾ ਮਾਲ ਰਿਕਾਰਡ ਵਿਚ ਕੋਈ ਇੰਦਰਾਜ਼ ਨਹੀਂ ਹੈ। ਇਸ ਕਰਕੇ ਮੁਤਾਬਿਕ ਰਿਕਾਰਡ ਕਾਰਵਾਈ ਨਹੀਂ ਕੀਤੀ ਜਾ ਸਕਦੀ ਹੈ ਜੀ।
