ORDER

The RTI application is dated 1.6.2020 vide which the complainant has sought information as enumerated in his RTI application. Complaint was filed in the Commission on 2.7.2021 under Section 18 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The representative of the respondents states that no information has been supplied to the appellant as the appellant is already advised to deposit the fee at the Suvidha Centre.

3. It is appropriate to mention the decision of the Hon'ble Supreme Court of India in Civil Appeal No. 5665/2014 – Institute of Companies Secretaries of India Vs Paras Jain, and the relevant portion of the same is reproduced below:-

"...Rule 4, The Right to Information (Regulation of Fees and Cost) Rules, 2005 which also entitles the candidates to seek inspection and certified copies of their answer scripts. In our opinion, the existence of these two avenues is not mutually exclusive and it is up to the candidate to choose either of the routes. Thus, if a candidate seeks information under the provisions of the Right to Information, then payment has to be sought under the Rules therein, however, if the information is sought under the Guidelines of the appellant, then the appellant is at liberty to charge the candidates as per its guidelines...."

4. It is also appropriate to mention the decision of the Hon'ble Punjab and Haryana High Court in Civil Writ Petition No. 12016 of 2016 in Shakti Singh Vs State Information Commission, Haryana and others, and the relevant portion of the same is reproduced below:-

"...12. The reply to this question is that there being no inconsistency under the RTI Act and the provisions of the other statute/law, the option and prerogative is with the citizen to select and choose to exercise his right under such Act/law or the RTI Act. In case the citizen prefers to move an application under the RTI Act, Public Information Officer, on receipt of such request, shall proceed to take a decision thereon and provide information as a norm and any denial of the same must be in accordance with Sections 8, 9 and 11 only. The right to information, thus, cannot be denied under

2. The appellant has sought the following information:-

3. The representative of the respondents filed the specific response regarding the sought information which is being **sent** to the appellant along with this order. The representative of the respondents also reiterated the same during the hearing.

4. The reply filed by the respondent is reproduced below:-

6. Keeping in view the submissions made by the respondent and the decisions of the Central Information Commission mentioned herein, the submission made by the respondent authority is accepted. Therefore, the Commission observes that no further action is required to be taken in this case. Hence, the case is disposed of and closed.

3. The representative of the respondent states that the reply of the deficiencies pointed out by the appellant has already been given. However the appellant states that there are number of pages copy of which has not been supplied and the same has been kept blank. She also states that she has received the compensation amounting to Rs.10,000/- as has been awarded by the Commission. Whereas the representative of the respondents states that the pages mentioned by the appellant was blank therefore the copy of the same was not provided to the appellant. Regarding bank statement the Representative of the respondent assured that the information pertaining to the bank statement of Punjab National Bank and UCO Bank along with the bill and quotations in accordance with the HDFC Bank statement will be supplied to the appellant within a week.

4. Sh. Dhanwant Singh, Block Development and Panchayats Officer also sent the written submissions vide which he has also requested to close the case. After consideration, the show cause notice issued to him is hereby withdrawn in this case.

5. In accordance with the assurance given by the representatives of the respondents that the remaining information will be supplied to the appellant within a week, the directions are issued to the respondent-Public Information Officer to supply the same within a week from the issue of this order. Since the Commission observes that no further action is required to be taken in this case, the case is disposed of and closed. However liberty is granted to the applicant to approach the Commission within four weeks in case the appellant does not receive the remaining information as enumerated above.

ORDER

The RTI application is dated 23.1.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 24.2.2020 and second appeal was filed in the Commission on 29.6.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the information pertaining to his arms licence No. 3063/DM/District Ludhiana/MCWR/Feb/2000 submitted to the Sewa Kendra, Tehsil Complex Machhiwara for the renewal vide receipt No. 111/11760/050219 dated 5.2.2019.

3. The representative of the respondents states that the arms licence has already been handed over to the appellant. However, the appellant states that he has received the same on 24.8.2021. but he has been harassed a lot for getting it. He also states that he has applied for the renewal of arms licence on 5.2.2019 whereas the licence has been handed over to him on 24.8.2021 after filing the RTI application on the same issue. He has also filed the written submissions in this regard, which are taken on record, and also requested that an enquiry must be marked to the Deputy Commissioner, District Ludhiana.

4. Accordingly, the submissions made by the appellant along with the RTI application is being **sent** to the Deputy Commissioner, District Ludhiana to look into the matter and take appropriate action as per Law.

5. With these directions, the Commission observes that no further action is required to be taken in this case. Hence, the case is disposed of and closed.
