Shri Harinder Pal Singh, appellant filed RTI application dated 06.07.2020 and sought some information from the SPIO, O/o E.O., Nagar Council, Nabha, Distt. Patiala.

Today the case is heard through CISCO Webex Meetings Software.

The appellant is present today, whereas the respondent SPIO is absent.

The appellant stated that as was directed vide Order dated 11.08.2021, he has visited the office of the SPIO on 12.08.2021, but the SPIO has not provided him the sought for information. He further stated that the SPIO has provided him the information regarding point no.1 of the RTI application, but the information regarding point nos.2, 3 and 4 of the RTI application is still pending.

Non compliance of the Order of the Commission would be viewed seriously and a Show Cause Notice U/s 20(1) of the RTI Act, 2005 will be issued to the SPIO on the next date of hearing and he will be penalized upto Rs.25,000/-.

Shri Tejinder Singh, Advocate, appellant filed RTI application dated 02.07.2019 and sought information from the SPIO, O/o Food Safety Officer, Patiala regarding registration and checking of canteens in central jails and academic institutions in the district for the period 2010 to 1st July, 2019.

Today the case is heard through CISCO Webex Meetings Software. The appellant is present today, whereas the respondent SPIO is absent. The appellant stated that neither the remaining information nor the amount of compensation of Rs.4,000/- has been provided to him by the SPIO.

I have gone through the Order dated 11.08.2021 and the respondent SPIO was directed to send the amount of compensation of Rs.4,000/- to the appellant along with the remaining information.

But the SPIO is absent today and neither she has complied with the Order of the Commission. So, a Show Cause Notice U/s 20(1) of the RTI Act, 2005 is issued to Ms. Gagandeep Kaur, SPIO-cum-Food Safety Officer, Patiala that why she is not obeying the Orders of the Commission and why she has not provided the complete information to the appellant and so why she may not be penalized up to Rs.25,000/-.

The SPIO should send the reply to the Show Cause Notice in writing and send the same to the Commission within 15 days and an opportunity of personal hearing will be afforded to her on the next date of hearing. In case she would not file reply to the Show Cause Notice, then it will be assumed that she do not want to say anything in her defence and the Show Cause Notice will be decided without hearing her on the next date of hearing. The SPIO is further directed to send the amount of compensation of Rs.4,000/- to the appellant from the funds of public authority by way of demand draft through registered post within 15 days along with the attested copies of remaining information.
