#### **ORDER**

The RTI request is dated 07.04.2022. First appeal is dated 21.05.2022. Second appeal has been received in the Commission on 04.07.2022.

2. Sh. Purshotam Kumar, A. S. I., who appeared on behalf of the respondent PIO in today's hearing, states that the information sought through RTI request is regarding 'Recruitment of Computer/Digital Forensic officer' alongwith 'Merit List' and 'Experience Certificates' of all the candidates and the said 'Recruitment' is under process, hence, the same is exempted from disclosure under Section 8 (1) (h) of the RTI Act. He also intimates that a reply has been sent to the appellant vide letter no. 2787 dated 15.06.2022 and a reply has also been sent to the Commission vide letter no. 3681 dated 04.08.2022 ( received in the Commission vide Diary No. 17438 dated 05.08.2022. Both the above-said replies are taken on record.

3. The appellant, Sh. Sham Lal Singla, who appeared in person in today's hearing, states that he has not received the above-mentioned letter dated 15.06.2022.

4. On this, Sh. Purshotam Kumar, A. S. I., hands over the above-mentioned letter dated 15.06.2022 to the appellant during the hearing in the Commission today.

5. After going through the reply, the appellant shown his dis-satisfaction over the same.

6. After examining the documents placed in the case-file, it is found that the information demanded through RTI request is regarding copies of Recruitment of Computer/Digital Forensic officer' alongwith 'Merit List' and 'Experience Certificates' of all the candidates, which is 'personal information' and through Para 59 of Decision dated 13.11.2019, the Hon'ble Supreme Court of India has defined 'Personal Information' under RTI Act, 2005 in a Civil Appeal no. 10044 of 2010 titled Central Public Information Officer, Supreme Court of India Vs. Subash Chander Agarwal .

7. Moreover, para 59 of Decision dated 13.11.2019, the Hon'ble Supreme Court of India, in Civil Appeal no. 10044 of 2010 titled Central Public Information Officer, Supreme Court of India Vs. Subash Chander Agarwal, has defined 'Personal Information' under RTI Act, 2005 and the relevant operative part of the Judgment is reproduced below ;

*"Reading of the aforesaid judicial precedents, in our opinion, would indicate that personal records, including name, address, physical, mental and psychological status, marks obtained, grades and answer sheets, are all treated as Personal Information. Similarly, professional records, including qualification, performance, evaluation reports, ACRs, disciplinary proceedings etc. are all Personal Information'. Medical records, treatment, choice of medicine, list of hospitals and doctors visited, findings recorded, including that of the family members, information relating to assets, liabilities, income tax returns, detail of investments, lending and borrowing, etc. are Personal Information'. Such 'Personal Information' is entitled to protection from unwarranted invasion of privacy and conditional access is available when stipulation invasion 'Larger Public Interest' is satisfied. This list is indicative and not exhaustive."*

8. After hearing both the parties and examining the documents placed in the case-file, it is found that information sought for by the appellant through his RTI request is 'personal information' in nature and hence can not be given to the information-seeker.

9. Hence, the above-mentioned appeal is not maintainable and announced as **disposed and closed.**



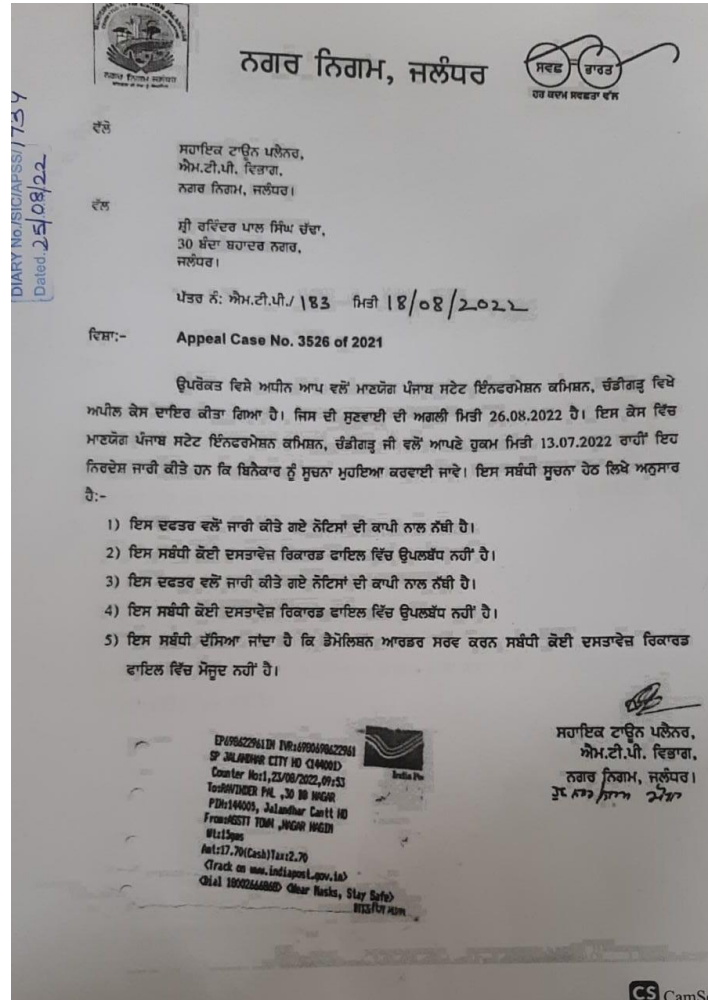
