ਉਕਤ ਵਿਸ਼ੇ ਦੇ ਸਬੰਧ ਵਿਚ ਆਪ ਵੱਲੋਂ ਪ੍ਰਾਪਤ ਹੋਈ ਦਰਖਾਸਤ ਮਿਤੀ:15.12.2018 ਦੀ ਪੜਤਾਲ ਉਪ ਮੰਡਲ ਮੈਜਿਸਟਰੇਟ ਲੁਧਿਆਣਾ ਪੱਛਮੀ ਪਾਸੇ ਕਰਵਾਈ ਗਈ।ਉਪ ਮੰਡਲ ਮੈਜਿਸਟਰੇਟ ਲੁਧਿਆਣਾ ਪੱਛਮੀ ਵੱਲੋਂ ਪੱਤਰ ਨੰਬਰ:2399 ਮਿਤੀ:5.9.2019 ਰਾਹੀਂ ਰਿਪੋਰਟ ਪ੍ਰਾਪਤ ਹੋਈ।ਜਿਸ ਅਨੁਸਾਰ ਸ੍ਰੀ ਜਸਬੀਰ ਸਿੰਘ ਜਨਰਲਿਸਟ ਪਿੰਡ ਭੋਲਪੁਰ ਵੱਲੋਂ ਪ੍ਰਾਪਤ ਦਰਖਾਸਤ ਮਿਤੀ:15.12.2018 ਦੀ ਕਾਪੀ ਅਤੇ ਪ੍ਰੈਸ ਕਟਿੰਗ ਦੀ ਕਾਪੀ ਨਿਮਨ ਹਸਤਾਖਰ ਪਾਸ ਭੇਜੀ ਗਈ ਸੀ।ਦਰਖਾਸਤ ਦੇ ਤੱਥਾਂ ਅਤੇ ਦੈਨਿਕ ਭਾਸਕਰ ਅਖਬਾਰ ਵਿਚ ਛਪੀ ਖਬਰ ਮਿਤੀ:21.11.2018 ਟਾਈਟਲ "ਪਰਪਾਰਟੀ ਕਰੀ,ਰਜਿਸਟਰੀ ਕਰੀ ਰੋਜ਼ 300 ਰਜਿਸਟਰੀਆਂ ਅਫਸਰੋਂ ਏਜੰਟੋਂ ਕੀ ਮਿਲੀ ਭੁਗਤ ਸੇ ਹਰ ਮਾਹ ਕਮ ਸੇ ਕਮ 1.5 ਕਰੋੜ ਕੀ ਸਟੈਪ ਡਿਊਟੀ ਚੋਰੀ" ਨੂੰ ਵਾਚਿਆ ਗਿਆ।ਦਰਖਾਸਤ ਕਰਤਾ ਵੱਲੋਂ ਮੰਗ ਕੀਤੀ ਗਈ ਕਿ ਇਸ ਮਾਮਲੇ ਦੀ ਜਾਂਚ ਕਰਵਾਈ ਜਾਵੇ।ਖਬਰ ਨੂੰ ਘੋਖਣ ਤੇ ਪਾਇਆ ਗਿਆ ਹੈ ਕਿ ਖਬਰ ਅਸਟਾਮ ਡਿਊਟੀ ਦੀ ਚੋਰੀ ਬਾਬਤ ਹੈ ਜਿਸ ਵਿਚ 5 ਇਲਾਕਿਆਂ ਵਿਚ ਘੱਟ ਰੇਟ ਤੇ ਹੋ ਰਹੀਆਂ ਰਜਿਸਟਰੀਆਂ ਦਾ ਜਿਕਰ ਕੀਤਾ ਹੈ,ਜਿਨ੍ਹਾਂ ਵਿਚੋਂ ਇਕ ਏਰੀਆ ਸਰਾਭਾ ਨਗਰ ਦਰਜ ਕੀਤਾ ਗਿਆ ਹੈ ਜੋ ਕਿ ਇਸ ਸਬ ਡਵੀਜ਼ਨ ਵਿਚ ਪੈਦਾ ਹੈ।ਬਾਕੀ ਦੇ 4 ਇਲਾਕੇ ਇੰਡਸਟਰੀਆ ਏਰੀਆ-ਏ/ਟਰਾਂਸਪੋਰਟ ਨਗਰ ਸਬ ਡਵੀਜ਼ਨ ਲੁਧਿਆਣਾ ਪੂਰਬੀ ਵਿਚ ਪੈਂਦੇ ਹਨ।ਇਸ ਖਬਰ ਵਿਚ ਇਹ ਦੋਸ਼ ਲਗਾਏ ਗਏ ਹਨ ਕਿ ਵੱਧ ਕੁਲੈਕਟਰ ਰੇਟਾਂ ਵਾਲੇ ਏਰੀਆ ਦੀ ਥਾਂ ਤੇ ਘੱਟ ਕੁਲੈਕਟਰ ਰੇਟ ਦਾ ਏਰੀਆ ਕੋਡ ਪਾ ਕੇ ਰਜਿਸਟਰੀਆਂ ਕਰਵਾਈਆਂ ਜਾਂਦੀਆਂ ਹਨ ਪ੍ਰੰਤੂ ਕਿਸੇ ਵਸੀਕੇ ਦਾ ਵੇਰਵਾ ਭਾਵ ਵਸੀਕਾ ਨੰਬਰ ਅਤੇ ਮਿਤੀ ਆਦਿ ਨਹੀਂ ਦਿੱਤੀ ਗਈ।ਜਿਸ ਨਾਲ ਮਾਮਲੇ ਦੀ ਪੜਤਾਲ ਕੀਤੀ ਜਾ ਸਕੇ।ਜੇਕਰ ਪੂਰਬੀ ਵੱਲੋਂ ਅਜਿਹੀ ਕੋਈ ਡੀਟੇਲ ਆਪ ਜੀ ਦਫਤਰ ਵਿਚ ਦਿੱਤੀ ਗਈ ਹੈ ਤਾਂ ਇਸ ਦਫਤਰ ਵਿਚ ਭੇਜਣ ਦੀ ਖੋਜ ਕੀਤੀ ਜਾਵੇ ਤਾਂ ਜੋ ਤੱਥਾਂ ਦੀ ਪੜਤਾਲ ਕੀਤੀ ਜਾ ਸਕੇ।ਅਜਿਹੀ ਕੋਈ ਡੀਟੇਲ ਹਾਲ ਦੀ ਘੜੀ ਦਫਤਰ ਵਿਚ ਉਪਬਲਾਧ ਨਾ ਹੋਣ ਕਾਰਨ ਦਰਖਾਸਤ ਦਾਖਲ ਦਫਤਰ ਕਰਨ ਦੀ ਸਿਫਾਰਸ਼ ਕੀਤੀ ਜਾਂਦੀ ਹੈ।

4. After going through the contents of letter mentioned above, it is observed that there are five areas in Ludhiana district, where more than 300 conveyance deeds are registered daily. The appellant has not mentioned any specific conveyance deed, where the stamp papers below the Collector Rates are affixed. It is difficult to look into each and every case to know, where the stamp duty below the Collector Rates is affixed. .No public authority is supposed to create, collate or generate information under the RTI Act on the asking of the information-seeker. Hence, the present case is disposed of and closed. Copies of the order be sent to the parties.
