ORDER

This order may be read with reference to the previous order dated 24.7.2020 vide which the show cause notice was issued to Sh. Paramjit Singh Panchayat Secretary and the Block Development and Panchayats Officer was directed to ensure the compliance of this order and the orders were sent to both through registered post and the case was adjourned to 26.8.2020 but due to administrative reasons the case was further adjourned to 7.10.2020.

- 2. The appellant states that the respondents are harassing him by not providing the complete information and he is being harassed. Shri Paramjit Singh, Panchayat Secretary-cum-PIO is absent as he was directed to remain present at Chandigarh as per the last order of the Commission along with the original record from which it has transpired that the respondent-Public Information Officer is absent wilfully so that the complete information could not be supplied.
- 3. The perusal of the file and the conduct of the respondent-PIO compelled the Commission to issue him a formal show cause notice on 24.7.2020 as to why action under Section 20(1) of the RTI Act 2005 should not be taken against him and he was also provided an opportunity to file his written reply and also make use of opportunity of personal hearing under the principles of natural justice. But neither the appellant made any submissions nor the complete information is being supplied to the appellant.
- 4. Since the responsibility to ensure timely transmission of the information to the appellant lies on the PIO, Shri Paramjit Singh, Panchayat Secretary o/o Block Development and Panchayats Officer, Block Bhogpur, Jalandhar is hereby held guilty for not providing the information on time as prescribed under Section 7 of the RTI Act, 2005, which is within 30 days of the receipt of the request for supply of information and for repeated and wilful defiance of the Punjab State Information Commission's orders.
- 5. Such kind of failure on the part of the respondent-PIO is totally unacceptable. It is pertinent to mention here that RTI Act has been enacted to ensure participative nature of management between the public & the public authorities and also to know as to what is happening behind the closed doors with regard to the governance affairs of the public authorities and their functioning.

- 6. After giving thoughtful consideration and due perusal of the facts of the case and the material available on record, I have come to the conclusion that he has failed to perform his duty as per the mandate of the RTI Act, which requires the public servant to ensure due transparency and accountability in its functioning. It has also come out that he has not only failed to perform his duty at his own level but also has shown his casual approach in complying with the explicit order of the Commission.
- 7. It has been further established from his conduct that he has failed to provide the information even after getting formal show cause notice from the Commission. This speaks volumes as to how much respect & regard he has in his mind to the provisions of the RTI Act, which mandates that all public authorities will ensure that the RTI Act, 2005 is duly implemented by them, whenever any citizen approaches the public authority to get any public information for which they have right to ask for as per the provisions of RTI Act. In view of the facts mentioned herein, I am of the considered view that Shri Paramjit Singh, Panchayat Secretary-cum-PIO o/o Block Development and Panchayats Officer, Block Bhogpur, Jalandhar should be penalised for his negligence in discharge of his statutory duty prescribed under the RTI Act. All his failure make me believe that his sheer neglect to perform his duties will be met only after he is duly taken to task as per the provisions of the RTI Act i.e. Section 20(1), which provides that any delay on the part of the respondent-PIO beyond 30 days is to be penalized @ 250/- per day and to the maximum of Rs. 25000/-
- 8. Under these circumstances, I am left with no other option but to decide the question of imposition of penalty and quantum thereof upon Shri Paramjit Singh, Panchayat Secretary-cum-PIO o/o Block Development and Panchayats Officer, Block Bhogpur, Jalandhar as per the provisions of the RTI Act i.e. Section 20(1) of the RTI Act, 2005. In this case the intervening period is too large, the respondent-PIO failed to comply with the orders of the Commission. Accordingly, a penalty of Rs. 5000/- (Rupees Five thousand only) is imposed on him.
- 9. The amount of penalty i.e. Rs. 5000/- (Rupees Five thousand only) should be deducted from his salary in two installments and be deposited in the Government treasury under head "0070-Other Administrative Services-60-Other Services-800-Other Receipts-86-Fees under the Right to Information Act. The Block Development and Panchayats Officer, Bhogpur, Jalandhar shall ensure that this amount of penalty is deducted from the salary of the above said defaulting official for the month of November, 2020 and December, 2020 and deposited in the Treasury under the relevant head and sent compliance report to the Commission on or before 20.01.2021.
- 10. Viewing the attitude in dealing with the RTI application of the appellant Ms. Manjinder Kaur, Public Information Officer o/o the Block Development and Panchayats Officer, Bhogpur is thus issued a show cause notice to explain in a self-attested affidavit as to why a compensation to the appellant for detriment suffered by him under section 19(8) of the RTI Act,2005 may not be awarded.

In addition to the written reply, the Public Information Officer is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before awarding the compensation on the next date of hearing. She may take a note that in case she does not

Order

This order may be read with reference to the previous order dated 28.8.2020 and was adjourned to 7.10.2020 due to the administrative reasons and further adjourned to 26.10.2020.

2. The appellant has sought the following information as per the RTI application dated 1.12.2014:-

- The appellant states that he has not received the information as has been sought vide his RTI application. He further states that the sought information is in possession of the concerned Block Development and Panchayat Officer/District Development Officer but he has denied the information on the pretext that the sought information is not available in the record. The appellant further states that Sub Divisional Officer/Executive Engineer, Panchayati Raj has not supplied any information so far.
- 3. However, the representative of the respondents states that the sought information relates to the different departments and letter no. 407 is not available in the record of the respondents. Furthermore, he states that the record being very old, he will try to trace the record once again and will update the Commission and the appellant before the next date of hearing. In addition, he also states that the appellant can inspect the record for his satisfaction. With regard to the information pertaining to Point No. 2 the representative of the respondents states that the same relates to the S.D.O./Executive Engineer, Panchayati Raj.
- After hearing both the parties, the representative of the respondents is hereby, directed to transfer the RTI application of the appellant to the concerned department under section 6(3) of the RTI Act, 2005 for the information pertaining to point no. 2 and update the status of the information which is in his possession before the next date of the hearing.
- 5. According to the submissions of the representative of the respondents the Public Information Officer o/o the Executive Engineer, Panchayati Raj and Public Information Officer o/o the Sub Divisional Engineer, Panchayati Raj is impleaded as necessary party in this case with the directions to file the reply/supply the information before the next date of hearing. 6. To come up on 4.12.2020 at 12.30 P.M. to be heard through the video conference facility available in the office of the Deputy Commissioner, Ludhiana.
