1. The RTI application is dated **24.2.2021** vide which the appellant has sought information **regarding the validity of the licenses issued to two stamp vendors**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **24.3.2021** and Second Appeal was filed in the Commission on **10.6.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **24.8.2021**.

2. Both parties are present. The appellant is present at this hearing via Cisco Webex. The respondent PIO represented by Rajni Khattar, Senior Assistant, is present via Video Conference Facility from Patiala. At the last hearing on 24.8.2021, the respondent PIO had supplied copies of licenses issued to the two stamp vendors cited in the RTI application. The appellant has acknowledged the receipt of the said copy but has pointed out that from the stated place of business in case of License No. 455 issued to Gurbaz Singh, it cannot be ascertained precisely where said license is being operated.

3. Following deliberations at this hearing, the respondent PIO was directed to provide the current address of the place of business of the stamp vendor to whom License No. 465 was issued. This must be done at the earliest.

4. As per the aforesaid direction, the respondent has, vide Letter No 2216 dated 26.10.2021, informed the appellant that License No. 455 was originally operating from Bhardwaj Property Dealer, Punjabi Bagh Colony, Patiala. However, consequent to an Order by the Deputy Commissioner Patiala dated 5.10.21, the aforesaid stamp vendor's place of business has now been shifted to the Tehsil Complex, Patiala.
