

With regard to Point No. 5 of the RTI application the respondent-Public Information Officer clarified that the record pertaining to proceeding book of appointment of mid day meal workers is not available as Sh. Sukhdhir Singh Sekhon, appellant has not given the charge of the same from 1.1.2010 to 31.12.2019. From 1.1.2020 to 31.1.2021, he filed the specific reply, which is taken on record. A copy of the same is also **being sent** to the appellant along with this order.
- 4. Keeping in view the above, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed.
