I., who appeared on behalf of the respondent PIO in today’s hearing, submit a reply vide letter no. 42265 dated 19.11.2018, showing that in response to the RTI request, a reply has already been given to the applicant, Ms. Ravneet Kaur vide letter no. 40725 dated 02.11.2018, intimating her that the information sought for by her through RTI request, is regarding an enquiry, which has not been completed yet. He also hands over a copy of the same to Sh. Ramandeep Singh Ahluwalia (representative of the applicant, Ms. Ravneet Kaur) during the hearing in the Commission today. Both the above said replies are taken on record.

I have gone over the contents of the responses given by the respondent concerned and of the considered view that no cause of action is required to be taken in this case, hence, the case is **disposed of and closed.**
