**ORDER**

This case was last heard on 11.09.2019 and another opportunity was given to both the parties (the respondent PIO and the appellant) to represent this case in person or through their representative so that the facts of this case could be cleared.

Sh. Narinder Kumar, Senior Assistant, who appeared on behalf of the respondent PIO in today's hearing, states that in response to the RTI request, the requisite information has already been supplied to the appellant, Sh. Jaspal Singh.

After examining the documents placed on record, it is found that the respondent PIO through a reply vide letter no. 7942 dated 21.11.2019 signed by Public Information Officer office of PEPSU Road Transport Corporation, Patiala, which has been received in the Commission vide Diary No. 22647 dated 25.11.2019, has intimated the Commission that the requisite information has already been supplied to the appellant, Sh. Jaspal Singh through registered post. It, alongwith a copy of supplied information, is taken on record.

The appellant, Sh. Jaspal Singh, who appeared in person in today's hearing, states that the information provided to him is not as per queries, raised by him through RTI request.

After going through the information, which has been given to the appellant is not as per queries, raised by the appellant through RTI request and not at all relates with the instant appeal case i. e. A. C. 1213 of 2019.

Due to evasive attitude of the respondent PIO concerned, a compensation of Rs. 2000/- (Rupees Two Thousand only) is hereby awarded to the appellant, Sh. Jaspal Singh. The compensation shall be paid by public authority concerned by way of crossed cheque/Demand Draft in the name of Jaspal Singh. The crossed cheque/Demand Draft shall be made from the bank account of public authority concerned and not from the individual official.

After examining the documents placed on record, it emerges that the RTI request of the appellant is dated 26.11.2018 and delay in this case is more than ten months and hence, for holding guilty of violation under Section 20 (1) as per provisions of the RTI Act and for making delay more than 250 days in supplying the requisite information to the information-seeker, a penalty of Rs. 2500/- (Rupees Twenty Five Hundred Only) is imposed upon the concerned Public Information Officer of office of PEPSU Road Transport Corporation, Patiala. A copy of this order be sent to him through registered post.

The amount of penalty will be deposited in the treasury of Punjab Government under the head.....

**ORDER**
