

However, the representative of the respondents states that the information sought by the applicant relates to Village Nanakpur Jagera, Tehsil Payal and the record has been seen upto 1963-64 and prior to this period the record is in Urdu. He further states that the copy of the Jamabandi of Lal Das Chela Bishan Das has been sent to the applicant with a copy to Commission. Furthermore, he states that a letter dated 26.4.2019 was issued to the appellant stating that in case any other record is still required he may come to office on any working day but nothing has been received from him and requests for the closure of the case.
- 3. As per the submissions of the representative of the respondents and record available on the file it transpires that no more cause of action is left in this case and the case is disposed of and closed. However, if the appellant is not satisfied with the information so provided, he is at liberty to approach the Commission for reconsideration within one month from the date of the issue of this order.
