Smt. Shivani Jaswal, appellant filed RTI application dated 15.03.2019 and sought some information from the PIO, O/o M.C., Nangal, Distt. Ropar.

I have gone through the RTI application dated 15.03.2019 filed by Smt. Shivani Jaswal, appellant and as stated by her counsel, she is the sitting councilor in the Municipal Council, Nangal. She has filed RTI application for getting some information from the office of the PIO.

The PIO wrote letter no.1221 dated 12.04.2019 to the appellant and asked her to visit the office of the PIO for making inspection of the relevant record as the information sought by the appellant is voluminous in size, but the appellant has not visited the office of the PIO for making inspection of the record.

I have gone through the Order dated 29.10.2019 and as per the Order a direction was issued to the appellant to visit the office of the PIO on 04.11.2019 at 10:00 A.M. and Shri Manjinder Singh, PIO-cum-EO, M.C. Nangal will be responsible to provide the relevant record to the appellant for inspection and provide attested copies of sought for information, specifically para-wise to the appellant within 3 days from the date of inspection.

**Appeal Case No. 3300 of 2019**

The Commission has received a mail sent by the PIO which was received in the office of the Commission on 22.11.2019 and diarized vide no.22575 and it is a copy of letter no.4468 dated 09.11.2019. I have gone through the said letter and it is submitted by the PIO that as per the Order passed by the Commission, Smt. Shivani Jaswal, appellant has not visited the office of the PIO on 04.11.2019 at 10:00, rather she has visited the office of the PIO on the same date at 3:30 P.M. along with her counsel and the relevant record was presented for inspection.

Letter no.4431 dated 06.11.2019 was sent to Smt. Shivani Jaswal, appellant by the PIO regarding the above said submissions.

Today at the time of hearing the PIO has submitted another letter no.4587 dated 25.11.2019 and in addition to the above said submissions and facts it is submitted in the letter that after 04.11.2019 till 25.11.2019 the appellant has not visited the office of the PIO regarding her claim.

As it is brought to the notice of the Commission that the appellant, Smt. Shivani Jaswal is the elected Municipal Councilor in the said Council and instead of the directions issued by the Commission she has not visited the office of the PIO on the said time and date given to her for the inspection rather she has visited the office of the PIO on same date at 3:30 P.M and the relevant record was presented to her for inspection and after that date till 25.11.2019 she has not visited the office of the PIO neither she submitted any application. It seems the appellant is not interested in getting the information that is why she has not complied with the Order of the Commission. So, the present appeal case is **disposed of and closed**.

**O R D E R**

Smt. Shivani Jaswal, appellant filed RTI application dated 12.03.2019 and she sought some information regarding the appointment of Shri Yudhvir Singh, JE/SDO who remained posted at office of M.C. Nangal from time to time.

I have gone through the Order dated 29.10.2019. The information was denied by the PIO, but I being not consented with the reply of the PIO directed the PIO to provide the sought for information to the appellant.

In compliance to the Order passed by the Commission the PIO submitted a copy of letter no.4496 dated 13.11.2019 through which the required information from annexure 1 to 10 was provided to the appellant, Smt. Shivani Jaswal. The information provided through annexures are a copy of Transfer Order dated 25.10.1999, copy of Transfer Order dated 20.06.2005, copy of Transfer Order dated 29.05.2009, copy of Transfer Order dated 22.06.2011, copy of Transfer Order dated 16.05.2012, copy of Transfer Order dated 01.01.2019, copy of Transfer Order dated 15.07.2014 and copy of Transfer Order dated 31.12.2014 and these transfer orders are related with the transfers of Shri Yudhvir Singh, JE/SDO transferred at Municipal Council, Nangal.

Advocate Manish Mehra, who is present on behalf of the appellant, Smt. Shivani Jaswal admitted that all these transfer orders were provided to the appellant by the PIO. Shri Manish Mehra, Advocate is claiming that though the appellant has received the transfer orders

but it has not been provided to the appellant that on which date Shri Yudhvir Singh, JE/SDO joined and on which date he was relieved.

The definition of information as defined U/s 2(f) of the RTI Act is very much clear which is as under :

“ ‘Information’ means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force.”

So, as per the definition of ‘information’ the documents related with the information which was available in the office of the PIO-cum-EO, M.C. Nangal regarding the transfers of Shri Yudhvir Singh, JE/SDO had already been provided and beyond this Advocate Manish Mehra, who appeared on behalf of the appellant is asking the answers to the queries which does not come within the ambit of the definition of information.

So, I am of the view that the information which was sought by the appellant regarding transfer of Shri Yudhvir Singh, JE/SDO had already been provided to the appellant by the PIO and he willfully provided the information as was sought by the appellant through her RTI application dated 12.03.2019. So, the present appeal case is **disposed of and closed**.

On the other hand Shri Arvind Markan, APIO stated that the RTI application dated 19.06.2019 filed by the complainant/applicant was received in the office of the PIO on 21.06.2019 and attested copies of 87 pages of information was sent to the complainant/applicant through RTI.6(33)18/32 dated 09.07.2019 through registered post.

**Complaint Case No. 912 of 2019**

The Commission has received a mail sent by the PIO on 15.11.2019 and diarized vide no.22044, which is a copy of letter no.73 dated 15.11.2019 along with copies of information.

I have gone through the above said letter and it is submitted in the letter that the copy of information sent and postal receipt as proof are attached herewith as Annexure R-2 and R-3. The registered postal letter is not returned back to the office of the PIO. So, as per the presumption the registered letter is drawn in favour of the respondent.

On the other hand Advocate Davinderpal Sood stated that the complainant/applicant has not received any reply to his RTI application dated 19.06.2019, which is incorrect. It is further submitted in para no.5 of the reply sent by Shri Satnam Singh Kaler, PIO-cum-Joint Director that the complainant/applicant, Shri S.P. Goyal had also filed a RTI application dated 16.04.2018 and the same information which he sought through the present RTI application dated 19.06.2019 was supplied to the complainant/applicant on 04.05.2018. It is further submitted that the information as available in the record of the answering respondent has already been supplied to him twice, so the present complaint case is not maintainable.

During the course of hearing through Video Conferencing a query was put up to Advocate Davinderpal Sood, who appeared on behalf of Shri S.P. Goyal that whether you know that the information was sent to the complainant/applicant through letter No.RTI.6(33)/18/32 dated 09.07.2019 and he replied that he personally has not knowledge, but Shri S.P. Goyal informed him that he has not received any information. Secondly it is brought to the notice of the Advocate, who appeared on behalf of the complainant/applicant that the information consisting of 87 pages was sent to the appellant through registered post vide letter no. RTI.6(33)/18/32 dated 09.07.2019 and the said registered letter has not received back in the office of the PIO. So, presumption is that the registered letter sent to the RTI.6(33)/18/32 dated 09.07.2019 is presumed to be delivered if a period of 30 days has been passed.

The Commission is of the view that as the RTI application dated 19.06.2019 which was received in the office of the PIO on 21.06.2019 and the information consisting of 87 pages was sent by the office of the PIO to the complainant/applicant through registered post on 09.07.2019. So, when the PIO has sent the sought for information to the complainant/applicant through registered post within the stipulated period of 30 days , then no complaint lies against the PIO.

**Complaint Case No. 912 of 2019**

Under the facts involved in the present complaint case, the present complaint case is disposed of and closed with a direction to the PIO that as the advocate of the complainant/applicant requested that once again the attested copies of sought for information be sent to the complainant/applicant through registered post at the address of the complainant/applicant given on his RTI application.

With this observation the present complaint case is **disposed of and closed**.
