The complainant, Sh. Makhan Singh, who appeared in person in today's hearing, states that he has received the documents from the concerned PIO but on the forwarding page of letter no. 1307 dated 13.11.2020, his father's name is written incorrect.

The appellant is advised to visit the office of the respondent PIO on any day during working hours to get the required documents (after getting it corrected) and the respondent PIO is directed to correct the name of father on the required documents and hand over the same to the a complainant during his visit to his (respondent PIO) office.

Both the parties mutually agreed to it during the hearing today.
