3. The representative of the respondents states that he has already supplied the sought information. Whereas the appellant states that he is satisfied with the information so supplied by the respondent pertianing to Point No. 1 to 6 of the RTI application. He further requested for the information in the public interest related to Point No. 7 of the RTI application. But the representative of the respondents states that the information cannot be supplied to the appellant being 3rd party.

4. After deliberations with both the parties, the directions are issued to the respondent-Public Information Officer to adopt the procedure mentioned under Section 11 of the RTI Act, 2005 and get the response from the 3rd party in this regard. After getting the 3rd party response, the respondent-Public Information Officer is further directed to take the appropriate decision and the same be conveyed to the appellant with a copy to the Commission within 15 days.

5. Also the reply has been received from Sh. Joginder Singh, Distt. Revenue Officer-cum-Public Information Officer vide which he has requested to withdraw the show cause notice issued to him in this case. Due to the retirement of Sh. Joginder Singh, Distt. Revenue Officer-cum-Public Information Officer and after consideration of the reply filed by him, a lenient view is taken in this case and the show cause notice issued to him is hereby withdrawn.

With these directions, the case is disposed of and closed. However, the liberty is granted to the appellant to approach the Commission within four weeks in case he is not satisifed/does not receive the decision of the respondent-Public Information Officer pertaining to Point No. 7 of the RTI application for the consideration.
