ORDER:

1. The RTI application is dated **29.12.2021** vide which the appellant has sought information **regarding promotion as Labour Inspector Grade I**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **9.2.2022** and Second Appeal was filed in the Commission on **17.6.2022** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **26.7.2022**.

2. Both parties are present. As per the respondent PIO-cum-Assistant Labour Commissioner, Harpreet Singh, the RTI application was referred to the First Appellate Authority for discussion since the requested information by way of agenda for promotion included several personal details of other employees and qualify for exemption as per Section 8(1)j of the RTI Act 2005. While at the hearing on 16.3.2022, the First Appellate Authority denied the information under Section 8(1)j of the RTI Act 2005.

3. During deliberation at this hearing, the Commission pointed out that personal details in said agenda documents could be redacted/blank out as per Section 10 of the RTI Act 2005, following which duly attested copies of the same be provided to the appellant with a copy to this Commission. The PIO is also requested to submit a copy of the FAA's Order of 16.3.2022, to the appellant as well as to the Commission. This must be done within 10 days of receipt of this Order.
