*normally those aspects are governed by the service rules which fall under the expression 'personal information', the disclosure of which has no relationship to any public activity or public interest. On the other hand, the disclosure of which could cause unwarranted invasion of the privacy of that individual. "*

4. After detailed deliberations with both the parties, the reply filed by the respondent pertaining to Point No. 1 to 3 of the RTI application is accepted and no directions are being issued to the respondents in this regard. However, concerning Point No. 4 & 5 of the RTI application the respondent Sh. Manoj Kumar submitted that no letter was issued by the school to appoint the government counsel. Accordingly, all the respondent-Public Information Officers are directed to send the undertaking that no letter was issued by the school to appoint the government counsel to defend case No. 745/2021 within a week with which the respondent-Public Information Officer agreed to.

5. With these directions the case is disposed of and closed. However, the appellant is at liberty to approach the Commission within two weeks in case he does not receive the same.

available in the public domain as per Para 7 (Point No. 12 of the RTI application) of the affidavit filed by the respondent Sh. Paramjit Singh, ATP-cum-APIO under intimation to the Commission and also provide the relevant link of the website to the appellant, if any;

(iii) to provide the status to the appellant as has been sought by him concerning Point No. 14 of the RTI application(2<sup>nd</sup> part) i.e.

“High Court order 20.3.2021 Justice Sr. Karambir Singh and Justice Sh. Rajan Gupta ji ਦਾ ਕੋਈ stay order ਸਾਰੇ ਪੰਜਾਬ ਲਈ ਹੈ ਤਾਂ ਇਸ ਸਭ supply ਕੀਤਾ ਜਾਵੇ ਜੀ।”

5. With regard to remaining information, no further directions can be given to the respondent as per the provisions of the RTI Act, 2005. However, the appellant has raised the issue regarding Mobile Tower installed in the residential area and no action is being taken by the department from the last two years.
