2. The Appellant states that requisite information has not been supplied by the respondents.

3. The representative of the PIO states that the appellant has suitably been intimated vide letter No.3597, dated 08.07.2021 that verification of her OBC certificate is under investigation by a constituted committee. The appellant states that she had joined the University in the year 2014 and verification of her above certificate had already been done by the concerned authorities in the year 2014 and she wants copy of that verification report only. The respondent is directed to supply the requisite information, duly certified, by registered post to the appellant before the next date of hearing under intimation to the Commission. He is further directed to be present on the next date of hearing through cisco webex to present the case.
