He also states that her cadre was not changed just the post was abolished. In relating to this, he mentions about the office order number 9024 /C-I dated 20.11.2002 and a letter vide endorsement number 8189 dated 03.12.2002, which is taken on record. The Respondent/ PIO is directed to submit the written decision taken report by Board of Directors in which it was decided that the post of the foreman has been abolished and she was asked to join as Sports Officer in year 2002 and to submit in writing that it was a fresh appointment, to the Commission as well as to the Appellant.

Relating to point number 02, as mentioned in the previous order dated 24.11.2020, Sh. J.S.Sandhu states that a self declaration dated 05.11.2020 signed by Ms. Madhuri Saxena has been submitted to the Appellant in which it has been clarified that Madhuri Saxena and Madhuri A Singh is the name of the same person. In this, the Respondent / PIO is directed that the department was asked to file an affidavit, as at the time of promotion the name had been changed or it was changed later, the Department was to supply the official documents which has been submitted by Madhuri Saxena at the time of name change. To which, Sh. J.S. Sandhu states that it was written by mistake, there was no official change and the fault was rectified in time. Sh. J.S. Sandhu is directed to submit the same in writing by filing a proper written reply as said by him or submit the copy of records to the Commission as well as to the Appellant; which had been submitted by Ms. Madhuri Saxena to the Concerned Department the time of name change.

Relating to point number 03, as mentioned in the previous order dated 24.11.2020, Sh. J.S.Sandhu states that this reply has already been submitted to the Commission as well as to the Appellant vide memo number 150 dated 14.08.2020 and the same has been discussed in the hearing dated 26.08.2020. To which, the Respondent / PIO is directed to clarify or present more proof on the same, as on this Ms. Yogita states that the facts mentioned by the Department in the memo number 150 which has been submitted in the Commission is false in nature.

The concerned PIO is directed to look into this matter and supply the information to the Appellant as discussed above.

The Respondent/PIO concerned is also directed to submit copy of postal receipt or submits a copy of an email (to the Commission), through which information would be sent to the Appellant, by the next date of hearing, positively.

The Appellant is directed to go through the requisite information, once he receives the same from the Respondent/PIO and point out deficiencies in written, **if any**, to the Respondent/PIO through registered post or through email, with a copy to the Commission, failing which the case will be decided on merits.

This case is adjourned to 03.05.2021 at 11:00 A.M.' and all the present persons are directed to be present on the next date of hearing i.e. 03.05.2021 which is going to be heard through Video Conference Software/ Application Cisco Webex Meetings. Meeting Id Number : 918782948.
