It is appropriate to mention the judgement given by the Hon'ble Supreme Court of India in Civil Appeal No. 9052 of 2012 (Arising out of SLP (C) No. 20217 of 2011) Bihar Public Service Commission Vs Saiyed Hussain Abbas Rizwi & Anr. and the relevant portion of the judgement is reproduced below:-
 - "..3. The satisfaction has to be arrived at by the authorities objectively and the consequences of such disclosure have to be weighed with regard to circumstances of a given case. The decision has to be based on objective satisfaction recorded for ensuring that larger public interest outweighs unwarranted invasion of privacy or other factors stated in the provision. Certain matters, particularly in relation to appointment, are required to be dealt with great confidentiality. The information may come to knowledge of the authority as a result of disclosure by others who give that information in confidence and with complete faith, integrity and fidelity. Secrecy of such information shall be maintained, thus, bringing it within the ambit of fiduciary capacity. Similarly, there may be cases where the disclosure has no relationship to any public activity or interest or it may even cause unwarranted invasion of privacy of the individual. All these protections have to be given their due implementation as they spring from statutory exemptions. It is not a decision simpliciter between private interest and public interest. It is a matter where a

constitutional protection is available to a person with regard to the right to privacy. Thus, the public interest has to be construed while keeping in mind the balance factor between right to privacy and right to information with the purpose sought to be achieved and the purpose that would be served in the larger public interest, particularly when both these rights emerge from the constitutional values under the Constitution of India.

- 3. After going through the record submitted by the appellant and keeping in view the judicial pronouncement mentioned herein, the plea taken by the respondent-Public Information Officer is overruled and the respondent-Public Information Officer is directed to supply the information as has been sought by the appellant and available on record with a copy to the Commission as the appellant is able to establish the larger public interest in disclosing the information.


