1. The RTI application is dated 24.06.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 25.07.2020 and the second appeal was filed in the Commission on 07.10.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

He is also directed to file a written reply to the show cause notice as to why the appellant should not be compensated for the mental harassment suffered by him in getting the information.

5. In addition to the written reply, PIO is hereby given an opportunity u/s 20(1) proviso thereto for a personal hearing before the imposition of such a penalty, on the next date of hearing. He may take note that in case he does not file the written reply and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceeding against him ex-parte.

6. The PIO is further directed to ensure that complete information is supplied to the appellant before the next hearing. He is also directed to attend the next hearing in person before the Bench at Chandigarh.

7. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 05.04.2021 at 11.30 AM before the Bench in Commission's Office at Chandigarh.** Copies of the order be sent to the concerned parties.
