Sh. Avtar Singh, Inspector of office of Vigilance Bureau, S. A. S. Nagar and Sh. Dheer Singh, A. S. I. (Economic Offences), appeared on behalf of the respondent in today's hearing.

After examining the documents placed on record, it is found that the respondent PIO had already sent a reply vide letter no. 59 dated 22.01.2019 signed by Public Information Officer-cum-Assistant Inspector General of Police, Vigilance Bureau, Punjab, S.A.S. Nagar, intimating the Commission that the information sought for by the applicant, Sh. Jasbir Singh, is regarding complaints, which are under investigation and the same is exempted from disclosure under Section 8 (1) (h) of the RTI Act, 2005 and the same reply has also been sent to the applicant through registered post. It, alongwith annexure, is placed in the case-file.

I have gone over the contents of the reply dated 22.01.2019, already placed in the case-file, I found it satisfactory.

As no cause of action is left in this case, the case is **disposed of and closed.**
