### **ORDER**

The Receipt Register maintained by Police Station Daba was summoned and on inspection it was found that the entry of Diary Number 659-5D related to one Smt. Sunita, 2157, Block-A, Giaspura Flat, Ludhiana whereas there is no entry of the application submitted by the appellant in the register on 20.02.2018. Thus it was observed that the appellant was being harassed un-necessarily and the orders passed by the PIO and the First

Appellate Authority did not reflect any depth in their sight and they simply endorsed the version of the officials. It was felt that the case in hand needed a thorough probe at the level of Deputy Commissioner of Police to find out as to whether there is any administrative lapse or there has been any wrong intent in dealing with the case and denying justice to the appellant. It was, therefore, directed that a detailed inquiry be conducted and completed before the next date of hearing and Action Taken Report be submitted. Also, Action Taken Report on the application dated 20.02.2018 submitted by the appellant be also submitted on the next date of hearing. The case was adjourned for today.

2. Today, the representative of the respondents submits an Inquiry Report concluding that no malafide has been proved. A copy of the Inquiry Report is handed over to the appellant and he is advised to file a fresh application with the concerned PIO for seeking requisite information.

3. Accordingly, the instant case is **disposed of and closed.**
