ORDER

1. This order may be read with the previous order dated 04.03.2021 vide which respondent Sh. Baljeet Singh stated that requisite information has already been sent to the appellant on 12.01.2021 through ordinary post but appellant denied of receiving of information through post.  - Point no. 2, 3 and 14 (after receiving letter regarding the specific required information from the appellant).
 - Exact link relates with Point No. 4
 - Name and contact numbers in connection with point no. 11
 - Car Numbers, registration number and allotted name in connection with point no. 12.
7. Both the parties are advised to co-operate on the appellant's visit along with advice to represent this case in person or through their representative(s) on the next date of hearing positively, failing to which case will be decided on merit basis.

5. Respondent, Sh. Baldev Singh is advised to co-operate and supply the relevant documents for inspection on the appellant's visit and provide the attested copy of the identified pages as per RTI application.
6. Both the parties are advised to represent this case in person or through their representative(s) who is well aware about the facts of this case, failing to which case will be decided on merit basis.
