## **ORDER**

1. This order may be raed with the previous order of the Commission dated 08.03.2021 vide which respondent Sh. Respondent PIO was directed to remove deficiency, if any, pointed out by the appellant as per RTI application. Both the parties are advised to represent this case in person or through their representative(s) who is well aware about the facts of this case, failing to which case will be decided on merit basis. Matter was adjourned for further hearing on 27.04.2021 i.e. today.

- 2. In today's hearing, representative of the appellant, Sh. Tejinder Singh states that requisite information has been received in this case and requested to close this case.
- Respondent, Sh. Sham Lal states that another same case (Appeal Case 1902 of 2020) is also pending before the Ld. SIC, Sh. Ajae Kumar Sharma with the same RTI application. He added that an email in this context was sent to the undersigned bench (which was received on 08.03.2021). This email is taken on record.
- 4. After hearing both the parties and examining the case files; present case (appeal case no. 8 of 2021) and another case (Appeal Case No. 1902 of 2020), it is observed that both RTI applications are same and with the Same IPO number, which is not permissible as per RTI Act, 2005. Appellant is advised to keep in mind while filing RTI applications.
- 5. As the information stands supplied, no further cause of action is required. Therefore, this instant appeal case is **disposed of and closed**. Copy of the order be sent to the parties.

It was observed that respondent PIO, O/o SDM, Samrala transferred the RTI application under Section 6(3) of the RTI Act to the respondent APIO, O/o Naib Tehsildar, Machhiwara vide letter no. 03/Superintendent/RTI dated 12.02.2021. A copy of previous order was sent to him through registered post.

Appellant was absent without any intimation to the Commission. One more opportunity is availed to the appellant to represent this case on the next date of hearing positively, failing to which case will be decided on merit basis.
