**ORDER**

1. To be read in continuity with earlier order dated 15.03.2021 vide which on the assurance of the respondent Sh. Sunil Kumar, to supply the sought information, the case was Disposed of, but he failed to do so. Accordingly on the request of the appellant the case has **reopened today**.
2. Respondent, Sh. Sunil Kumar pleaded that he had furnished all the relevant record files for inspection and had also provided the copies of documents so identified by the appellant.
3. On this, appellant's representative, Sh. Amardeep Singh contended that incorrect and misleading documents were presented before him for record inspection.
4. Keeping in view the facts of the case and the submissions made by both the parties, it is evident that no satisfactory reply had been provided by the respondent in the matter, which is a grave violation of the provisions of the RTI Act, 2005. The Commission therefore, directs the respondent to provide a clear and specific information to the Appellant within a period of 15 days in accordance with the provisions of the RTI Act, 2005, from the date of receipt of this order.

**The Respondent is moreover, cautioned to exercise due care in future to ensure that correct and complete information is furnished timely to the RTI applicant(s) as per provisions of the Act failing which penal proceedings under Section 20 shall be initiated.**
