Regarding information at point no. 02, 03, 04, 05, 06, 07 and 08 of the RTI request, the respondent stated that information is not available in the official record.

After examining the documents placed on record, it is found that in the abovementioned reply, on some of the points of the RTI request, the respondent has replied that the record is not available in the official record and this reply of respondent at present stage i. e. after nine months of the proceedings of this case, is not acceptable.

Last opportunity is given to the respondent PIO concerned to file a proper reply to the queries raised by the Appellant through RTI request, mentioning that if any Committee was constituted to frame guidelines/instructions for spending the Student Welfare Fund by each Private ITI collected by Private ITIs from students, also mentioning whether abovementioned guidelines/instructions, if made, have been conveyed to the Government ITIs and PVT. Racchpal Singh, Senior Assistant, who appeared on behalf of the respondent PIO in today's hearing, submit a reply vide letter no.1746 dated 27.05.2019, showing that a point-wise reply to each and every query raised by the complainant has been brought in the Commission. They also hand over the requisite information to Nikhil Batta, Advocate (representative of the complainant) during the hearing in the Commission today. It is taken on record.

After going through the supplied information, Sh. Nikhil Batta, Advocate, who appeared on behalf of the Complainant, Sh. Labh Singh Sandhu in today's hearing, orally point out certain deficiencies to the representatives of the respondent during the hearing in the Commission today.

After examining the documents placed on record and hearing both the parties concerned, it emerges that information at point no. 05 of the RTI request was exempted in earlier hearing of this case vide orders dated 03.12.2018. Regarding Information at point no. 01 of RTI request, the respondent concerned has brought the information in the Commission to be handed over to the Appellant. Regarding point no. 02, 03, 04, 06 and 07, the respondent stated that information is not available in the official record.

After examining the documents placed on record, it is found that in the abovementioned reply, on some of the points of the RTI request, the respondent has replied that the record is not available in the official record and this reply of respondent at present stage i. e. after nine months of the proceedings of this case, is not acceptable.

Last opportunity is given to the respondent PIO concerned to file a proper reply to the queries raised by the Appellant through RTI request, mentioning that if any Committee was constituted to frame guidelines/instructions for spending of Library, Medical, Student Fund and PITSA fund by each Government ITI or collected by Government IT students alongwith status reports spending of Library, Medical, Student Fund and PITSA fund by each Government ITI, mentioning whether abovementioned guidelines/instructions, if made, have been conveyed to the Government ITIs or not and send the same to the complainant through registered post before the next date of hearing with a copy to the Commission.

After examining the documents placed on record, it emerges that the requisite information has not been supplied by the respondent PIO to the information seeker even after a period of more one year.

In view of the above, a show cause notice under Section 20 (1) of the RTI Act is issued to Public Information Officer office of Director, Technical Education & Industrial Training Deptt., , as to why penalty be not imposed upon him for willful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the information-seeker under the provisions of the RTI Act, 2005.

The PIO is also hereby given an opportunity under Section 20(1) provision, thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him exparte.
