5. After perusing the documents placed on record and hearing both the parties, it is ascertained that the Appellant is not satisfied with the information provided. Today, the RTI has been discussed between both the parties. Accordingly, the Respondent-PIO is directed to provide information regarding the leave record of Sh Major Singh dated 23.10.2018 however, the purpose of the same may be withheld. Further, the Respondent is directed to provide Rawangi and Vapsi of the said employee only regarding the case no. 144 of the Appellant. The Respondent assures the Commission that the available information will be provided to the Appellant within 30 days. The Appellant has expressed his satisfaction over the same.

6. On the assurance of the Respondent to provide the available information, the Appeal case filed by the Appellant is **disposed off and closed**. Copy of the orders be sent to the parties.
