ORDER

Heard through facility of Software/application 'CISCO Webex Meetings'.

This case was earlier fixed for hearing for 20.04.2020 (was postponed)
and fixed for hearing for today.

The appellant, Sh. Rakesh Kumar Gupta, who appeared in person in
today's hearing, states that no information has been supplied to him by the respondent
PIO till date.

Sh. Gurdeep Singh, Superintendent, who appeared in person in today's
hearing, states that a reply has been sent to the appellant vide letter no. 6280 dated
02.06.2020, intimating him that he has not mentioned the complaint/complaints
regarding which he is seeking information, accordingly, he was asked to specify the
required information.

After examining the documents placed on record, it is found that the
respondent PIO through a reply vide letter no. 7185 dated 24.07.2020 signed by Deputy
Director, Urban Local Bodies, Pb., Ludhiana, which has been received in the
Commission through an e-mail, has intimated the Commission that a reply has been
sent to the appellant vide letter no. 6280 dated 02.06.2020, intimating him that he has
not mentioned the complaint/complaints regarding which he is seeking information,
accordingly, he was asked to specify the required information. It, alongwith above-
mentioned reply sent vide letter no. 6280 dated 02.06.2020, is taken on record.

An opportunity is given to him to the appellant to specify the required information, connected with the RTI request in this particular case, in writing, and send the same to the respondent PIO concerned so that information could be provided to him.

Last and final opportunity is given to the respondent PIO concerned to supply the required information (which would be specified by the appellant in this particular case), as per record available in the instant appeal case-file, to the appellant well in time and send forwarding letter of the same with acknowledgement receipt signed by the appellant to the Commission.

An opportunity is also given to the appellant to intimate the Commission whether he has received the information, which would be supplied to him by the respondent PIO or not, by the next date of hearing.

The case is **adjourned to 5th October, 2020 (Monday) at 11:00 A. M. for hearing through facility of Software/application 'CISCO Webex Meetings'.**
