

Maiser Khana, Bathinda and Sabha is managed by executives elected or selected by the members of the Sabha at regular interval. 2) That the present executive of Malwa Prantiya Sabha took over the duties and responsibility of the Sabha in February 2016 and the management of the college was taken over in May 2016. 3) That at the time of handing over of the charge of the Sabha, the previous president Shri Somjeet Pal Sharma passed a resolution No. 28,*

*dated 11.03.2016 wherein it was stated by him that being the president of the Sabha, many cases are pending against him in various courts and thus the records/registers of the Sabha and College is needed by him for producing in those cases therefore he took all the registered and records pertaining to Sabha and college while leaving the Sabha. The said resolution was signed by many people including the president. 4) That letter dated 31.01.2017 was written to Mr. Somjeet Sharma and Mr. Om Parkash Sharma (previous executing) for the returning of said record/register but no response was receive from there said. 5) That legal notice dated 18.09.2020 was also issue to Vishavjeet Pal Sharma and Mr. Om Parkash Sharma and currently a civil suit was filed in the court of Civil Judge Junior Division, Talwandi, Bathinda for the recovery of said record/registers of Sabha and College and same is pending for 22.09.2021. 6) That as and when the said record is received back from the previous executive, the information demanded by Mr. Vishavjit Pal will be delivered to him."*
