# **APPEAL CASE NO.4576 OF 2021**

#### PRESENT: None for the Appellant Sh.Manjit Singh, Asstt, Registrar-cum-PIO for the Respondent

ORDER:

The appellant, through an RTI application dated 15.10.2020, has sought information on 19 points regarding a copy of the letter/email/communication vide which the Solar energy Corporation of India approached by GNDU and conveyed willingness in install the rooftop solar panels - name & date of per person deputed by the SECI to GNDU- a copy of the letter from SECI vide rooftop capacity was approved – a copy of letter from SECI vide it directed AZURE POWER ROOF PROOF TPO ONE PVT LTD to implement the said project - list of companies who submitted their LOI for the said project - a copy of the notes and comments of the officers who approved the consent letter and other information as enumerated in the RTI application from the office of Guru Nanak Dev University, Amritsar. The appellant was not provided with the information provided, after which the appellant filed the first appeal before the First Appellate Authority on 04.2021, which did not decide on the appeal.

The case last came up for hearing through CISCO WEBEX on 09.12.2021 in the Bench of Shri Hem Inder Singh, State Information Commissioner, who demitted the office on 22.12.2021. The case was reallocated to the bench of the undersigned.

## Hearing dated 27.07.2022:

The case has come up for hearing today through video conferencing at DAC Amritsar/Hoshiarpur. As per the respondent, the information was sent to the appellant by registered post on 20.11.2020 and 08.02.2021 at his Amritsar address, which was, returned to their office as undelivered. The respondent further pleaded that the same information was then sent to the appellant at his Hoshiarpur address on 07.12.2021, and the appellant has received the same.

The appellant is absent nor represented. The appellant was also absent on 09.12.2021.

Having gone through the RTI application and hearing the respondent, The Commission observes that the RTI application has sufficiently been attended to and information to the best extent has been supplied to the appellant by the respondent. The appellant is absent consecutively for the second time without any communication to the Commission. No further interference of the commission is required in the matter; hence, the case is disposed of.
