Both the parties are absent today.

The PIO though is absent today, but he has sent a mail to the Commission on 18.08.2020, diarized vide no.10158, which is a copy of letter no.743 dated 11.08.2020. I have gone through the said letter and it is addressed to the Commission and a copy of the same is sent to the appellant. The PIO submitted in the letter that the appellant sought information regarding the release order of wheat during the period 01.01.2012 to 31.12.2013, but during this period no wheat was carried out by the PUNGRAIN, Sri Muktsar Sahib, so the information sought by the appellant does not exist in the office of the PIO.

I have gone through the RTI application dated 14.10.2019 filed by the appellant and he sought information regarding the release order of wheat given to the Food Supply Department (PUNGRAIN) during the period 01.01.2012 to 31.12.2013 and the PIO submitted in his reply that during this period no wheat was carried out by the PUNGRAIN, Sri Muktsar Sahib.

When the information sought by the appellant does not exist in the office of the PIO, so the PIO is unable to provide it to the appellant. Hence the present appeal case is **disposed of and closed.**
