## Appeal Case No.1644 of 2018

### Present:

The Appellant, Sh. Tejinder Singh is Absent.

Today, Sh.Pankaj Kalia, Sr.Asstt. who is present on behalf of PIO/Respondent states that they have supplied the complete information.

After going through the case file, it is observed that the Appellant has been absent on all the last five dates of hearing. It appears that either he has received the information and is satisfied with the same or he is no more interested in pursuing the matter.

In view of the above, **the case is disposed of and is closed.**

## Appeal Case No.1683 of 2018

**Present:** The Appellant, Sh. Gulshan Kumar is absent.  
Nobody is present on behalf of the PIO/Respondent.

### ORDER:

The case was last heard on 09.10.2018. The appellant Shri Gulshan Kumar was absent. But he had sent an e.mail. dated 09.10.2018 stating that due to an accident, he would not be able to appear in the hearing on that day. He had, therefore, requested for an adjournment in the case.

None was present on behalf of PIO/Respondent, as such, no statement could be recorded.

After going through the case file and the documents placed on record, the request of Appellant Sh.Gulshan Kumar was accepted. It was observed that the Respondent/PIO was absent on the last two hearings on 08.08.2018 and 05.07.2018. He was directed to supply the requisite information to the Appellant before next date of hearing but he failed to do so.

In view of the failure of the PIO/Respondent to supply the information to the Appellant in spite of directions of the Commission, Show Cause Notice under Section 20(1) of the RTI Act was issued to the PIO/Respondent. He was also given an opportunity under Section 20(1) provisions thereto, for a personal hearing with the sought for information before the imposition of such penalty on the next date of hearing.

**Appeal Case No. 1683 of 2018**

It is also observed that respondent/PIO has not supplied the requisite information to the appellant till date. I am of the view that due to evasive attitude of the Respondent/PIO concerned, the applicant has suffered a lot. **Therefore, compensation be awarded to the Appellant Sh. Gulshan Kumar.**

**Hence, I award a compensation of Rs. 2,000/- (Two Thousand) to the Appellant. The compensation amount must be paid by the Respondent/PIO concerned through cheque or demand draft in favor of Gulshan Kumar from the account of Public Authority and not from the individual's account.**

Respondent/PIO is directed to produce a copy of the cheque or demand draft on the next date of hearing.

PIO/Respondent may note that in case he does not supply the requisite information to the appellant, file his submissions and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.
