- 3. Sh. Harinder Singh, DSP is appearing on behalf of the PIO and files an affidavit which was given by Dr. Ketan Baliram Patil, IPS, SSP, Fazilka, which is taken on record.
- 4. During the last hearing, the PIO was directed either to provide the information or to file an affidavit, if the sought for information is not available in their office record. At today's hearing, an affidavit has been sent by the SSP, Fazilka, which has been filed by Sh. Harinder Singh, DSP today in the Commission, not by the PIO i.e DIG, Ferozepur.
- 5. Last opportunity is given to the PIO i.e DIG, Ferozepur to appear personally alongwith a proper affidavit duly attested by the higher authorities, on the next date of hearing, failing which action under Section 20(1) of the RTI Act, 2005 will be initiated.
- 6. The case is adjourned for **17.01.2018 at 11:00 AM**. Copies of the order be sent to the parties.
