**ORDER**

This case was last heard on 16.09.2019 with the directions to the Respondent/PIO to supply the requisite information to the Appellant before the next date of hearing.

In today's hearing, the representative of the Appellant, Sh. Jasbir Singh states that only the information relating to point no.5 is pending and requested to provide the same.

The representative of the Respondent/PIO, Sh. Tirath Singh handed over a letter vide endorsement no. 9069 dated 22.11.2019 along with a letter no. 47/MVI/PAT in which at point no.5 it is written that the Appellant has to deposit the assessed fee of Rs.520/- for the information relating to point no.5.

After going through the case file and discussing with both the parties it is observed that on the previous hearing 16.09.2019 the Advocate Sh. G.S. Kahlon was present on behalf of the Respondent/PIO and he orally stated that the Appellant was unable to deposit the assessed fees i.e. Rs. 300/- for the requisite information. Further on the previous hearing, the Respondent/PIO was directed to supply the certified copies of requisite information "free of cost", but still incomplete information has been supplied. And in today's hearing, Sh. Tirath Singh produces a document in the Court through which the Respondent / PIO is asking for assessed fees of Rs.520/- against point no. 5, which is un-acceptable. The Commission takes a serious view of this casual evasive approach against the Respondent/PIO as Respondent/PIO is unable to comply with the previous hearing dated 16.09.2019.

A last opportunity is given to the Respondent/PIO (O/o The Secretary, RTA, Patiala) and he is directed to supply complete information to the Appellant 'free of cost', by registered post before the next date of hearing. The PIO (O/o The Secretary, RTA, Patiala) is further directed to appear in person along with the postal receipt, through which information would be sent to the Appellant, on the next date of hearing. **Apart from this, The Motor Vehicle**



**Inspector, O/o Secretary, Regional Transport Authority, Patiala is directed to appear in person along with the information on the next date of hearing failing which strict action will be taken against him.**

**A copy of this order be sent to the O/o Secretary, Regional Transport Authority, Patiala, through registered post along with the RTI Application for his ready reference.**

The Appellant is advised to go through the requisite information, once he receives the same from the Respondent/PIO and point out deficiencies in written, if any, to the Respondent/PIO through registered post, with a copy to the Commission, failing which the case will be decided on merits.
