In the above said appeal case the Hon'ble State Information Commissioner, Shri Alwinder Pal Singh Pakhoke vide Order dated 25.05.2017 imposed a penalty of Rs. 25,000/- upon Shri Pawan Kumar Gulati PIO, O/o Tehsildar Moga. The PIO approached the Hon'ble High Court of Punjab and Haryana through CWP No. 22783 of 2017 and the CWP filed by the PIO, Shri Pawan Kumari Gulati was dismissed by the Hon'ble Justice Augustine George Masih vide order dated 19.08.2019. So, the Order of imposition of penalty is still in force.

I have gone through the Order dated 22.10.2019 and the DRO, O/o Deputy Commissioner, Moga was directed that an amount of Rs. 25,000/- which was imposed as penalty upon Shri Pawan Kumari Gulati, PIO, O/o Tehsildar, Moga be deducted from his salary and be deposited in the Govt. Treasury in the following heads:-

Present:- Shri Manjit Singh, complainant/applicant is present.  
None is present on behalf of Inspector Rajiv Kumar, PIO-cum-SHO, Police Station, Mattaur.

**O R D E R**

I have gone through the Order dated 22.10.2019 and a Show Cause Notice was issued to Inspection Rajiv Kumar, PIO-cum-SHO, Police Station Mattaur that why you are not coming present before the Commission at the time of hearing and why you have not filed reply to the complaint filed by the complainant/applicant and so why you may not be penalized under the provisions of the RTI Act, 2005.

The office of SSP, Mohali wrote letters to SHO, Police Station, Mattaur to appear before the Commission on the dates of hearing, but inspite of all this Inspector Rajiv Kumar, PIO-cum-SHO is not coming present. The conduct of Inspector Rajiv Kumar is condemnable and it amounts to defiance of the provisions of the RTI Act, law and towards his duties. Today, again he has not come present neither he provided the information to the complainant-applicant which was sought by him through his RTI application dated 05.05.2018.

A last and final opportunity is granted to Inspector Rajiv Kumar, PIO-cum-SHO, Police Station Mattaur that he should personally come present before the Commission on the next date of hearing and file reply to the complaint filed by the complainant-applicant and also file reply to the Show Cause Notice and an opportunity of personal hearing will be afforded to him. In case, he would not come present and would not file reply to the Show Cause Notice then the Show Cause Notice will be decided in his absence on the basis of papers available in the file.

**Complaint Case No. 62 of 2019**

A penalty of Rs. 25,000/- was imposed on Inspector Jagdev Singh No. 83/RR, the then PIO-cum-SHO, P.S. Mattaur, presently posted in the office of Commissionerate of Police, Ludhiana and the Drawing and Distribution Officer, O/o the Commissionerate of Police, Ludhiana was directed that the amount of penalty of Rs. 25,000/- be deducted from the salary of Inspector Jagdev Singh for the month of October, 2019. But no compliance report has been received in the office of the Commission regarding the deduction of amount of penalty from the salary of Inspector Jagdev Singh.

So, the Drawing and Distribution Officer, O/o the Commissionerate of Police, Ludhiana is directed that the amount of penalty of Rs. 25,000/- be deducted from the salary of Inspector Jagdev Singh and compliance report be sent back to the Commission.
