- 1. The RTI application is dated 17.1.2019 vide which the appellant has sought information regarding FIR No. 174 dated 18.12.2019 u/s 420/447/506/120-V/34 IPC, as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on 17.2.2020 and second appeal was filed in the Commission on 18.6.2020 under Section 19 of the Right to Information Act. 2005. The case was last heard on 21.8.2020.
- 2. The appellant is absent without any intimation. The respondent PIO, represented at this hearing by SP Headquarters-cum-APIO, Mohan Lal, present through Video Conference facility at the office of the Deputy Commissioner Fazilka, has sought exemption(vide Letter No. 1347 dated 2.11.2020) from disclosing the requested information contending that FIR 174 dated 18.12.2019, cited in the RTI application, is still under investigation. He also informed the Court that the case/FIR pertains to charges of cheating etc. against the appellant himself, which he is seeking to have quashed in the High Court.
- 3. In view of the respondent PIO's contentions made in his reply as well as during these proceedings, this Commission feels that there is no further cause for action and this appeal case is herewith **CLOSED**.
