finalization. She further submits that the information will be supplied to the appellant as and when the matter will be decided by the competent authority. She also submits that an affidavit has already been filed in this case.

4. The decision regarding penalty amounting to Rs.5000/- as has been imposed upon the Public Information Officer o/o the Secretary to Govt. of Punjab (LG 3 Branch) will be decided on the next date of hearing.
